CRS 42-3-115. Registration upon transfer.

(2) (a) Except as provided in paragraph (b) of this subsection (2), the transferee, before operating or permitting the operation of a motor vehicle upon a highway, shall register the vehicle.

(b) A transferee may operate a motor vehicle on the highway before registering it if: (I) The vehicle is exempt from registration pursuant to section 42-3-103 or 42-3-104; or (II) The vehicle has been temporarily registered pursuant to section 42-3-203 (3); or (III) (A) The transferee has purchased the motor vehicle within the last **thirty-six hours** from a person who is not a motor vehicle dealer under article 6 of title 12, C.R.S.; (B) The vehicle was purchased either on a Saturday, on a Sunday, on a legal holiday, or between 5 p.m. and 8 a.m.; (C) The vehicle is being driven from the place where the transferor stored the vehicle to the place where the transferee intends to store the vehicle; (D) The owner possesses, in the vehicle, a bill of sale that shows the time and date of sale and that is signed by both the buyer and seller; and (E) The owner possesses, in the vehicle, proof of insurance as required by section 42-4-1409.
